## President's Open Remarks

## <u>Presentation: Al and Its Use in Local Government – Demonstration of Chat GPT</u>

Stephanie Teoli Kuhls welcomed and provided an introduction of Dr. Dylan Hayden. Dr. Hayden is a seasoned public leader and a trailblazer in integrating AI and emerging technologies in government. Dr. Hayden has combined his deep knowledge of policy and administration with cutting-edge tech insights.

Dr. Hayden explained in detail exactly what AI is and what some of the AI Tools/Platforms are. He explained that there are various versions of Chat GPT being offered – free/paid for versions. He provided a brief presentation on how to get started with using AI.

Dr. Hayden then spent a couple minutes discussing how AI can be used in local government. He was able to review some examples and case studies of how cities are using AI. He reviewed the importance of creativity in prompt writing.

Ms. Teoli Kuhls demonstrated five examples of Middletown Township's use of AI on Ghat GPT over the past couple months.

Ms. Teoli Kuhls and Dr. Hayden follow up with their demonstrations with questions from the membership.

Ms. Marencik thanked Ms. Teoli Kuhls and Dr. Hayden for their time and participation in today's demonstration.

Carol Bigham, Delaware Valley Trust noted to Ms. Teoli Kuhls and Dr. Hayden that this would be a great training to add at the Delaware Valley Trust.
