Presentations:

Sign Season – Regulating and Enforcing Permanent and Temporary Signs in an Election Year

Mark L. Freed, Esq., and Andrew P. Griffin, Esq. from Curtin & Heefner, LLP gave an overview of regulating and enforcing short-term temporary signs. Areas highlighted in the presentation included: Ordinances Allowed, Ordinance Example and Enforcement. See attached for a full copy of the presentation.

Mike Italia, BCO,CZO, Barry Isett, asked Mr. Griffin to clarify the enforcement of Zoning Enforcement Notices (ZEN). Mr. Griffin advised that the Magistrate views the enforcement of a ZEN as a civil matter not criminal.

John Ramey, Warminster Township, questioned what separates a flag from a sign. Mr. Freed advised that there is no good distinction of the two. Individuals try to stay clear of enforcing/regulating flags. Kyle Seckinger, Warwick Township, questioned enforcement if the flag or sign contains something obscene. Mr. Freed suggested enforcing the item as an obscene message not a sign enforcement.

Linda Reid, Perkasie Borough, questioned enforcement of murals. Mr. Freed advised members to follow Township policy when it comes to a mural.

Mr. Garges thanked Mr. Freed and Mr. Griffin for their presentation.

CONTENT NEUTRAL

- •*Reed v. Town of Gilbert*, 576 U.S 155 (2015)
 - Temporary Signs Announcing Church Services

CONTENT NEUTRAL

- •"[H]ow any ordinary reader would know what category the signs belongs in"
 - Camp Hill Borough Republican Association v. Borough of Camp Hill, 101 F.4th 266 (3d Cir. 2024)
 - Regulation of "Personal Expression Signs" Not Content Neutral

CONTENT NEUTRAL

- •Ordinance <u>not</u> content based merely because speech or expression must be examined.
- Question is whether ordinance discriminates based on topic discussed or idea or message expressed.

CONTENT NEUTRAL

- •Ordinance that distinguished between signs for on-premises and off-premises products, locations and services content neutral.
 - City of Austin v. Reagan National Advertising of Austin, 596 U.S. 61 (2022)
- Reasonable Time, Place and Manner Regulations Permissible

CONTENT NEUTRAL

- •If ordinance not content neutral, may still be permissible if meets Strict Scrutiny:
 - Narrowly tailored
 - To meet compelling government interest
- Very High Standard

CONTENT NEUTRAL

•Even if facially content neutral, may still be content based if evidence of impermissible purpose or justification



SOLEBURY TOWNSHIP

- No Reference to "Political Signs"
- "Short-Term Temporary Signs"
 - •A sign that is nonpermanent that can be displayed for 45 days, but is not intended to be displayed for any indefinite period
 - Maximum sign size: six squa Coll SURTINGHEEFNER LE

SOLEBURY TOWNSHIP

- Permit Required
 - •Except for short-term temporary signs placed on private property by the owner or occupant of the property



ENFORCEMENT

Often Part of Zoning Code

- Zoning Code Subject to Municipalities Planning Code Enforcement Requirements
 - Zoning Enforcement Notice (ZEN)
 - Appeal to Zoning Hearing Board Stays ZEN

ENFORCEMENT

Possible Solutions

- Pursue Special Injunctive Action
 - MPC provision providing that failure to comply with zoning enforcement notice within time specified, unless extended by appeal to zoning hearing board, constitutes violation, does not grant landowners a stay of injunction. *Township of Madencreek v. Stutzman*, 642 A.2d 600 (Pa. Cmwlth. 1994)
- Codify Sign Regulations in Non-MPC Ordinance





21 native trees planted at Poole's Corner (2020) including magnolia, red bud, white oak, tupelo and locust trees


24 native trees planted in honor of Arbor Day (2023) at the disc golf course with assistance from local scout troop
